I will not use my program for solicitations of funds or anything of value. I will obtain written authorization for material or performances that require copyright or trademark authorization.

I understand that Greensboro Community Television has no control over content, therefore as a member/associate I accept full responsibility for program content, and agree to indemnify and hold harmless Greensboro Community Television, Inc., members of the board of directors, the City of Greensboro or Time Warner Cable, Inc. for any and all liability or other injury (including cost of defending claims or suits) arising from or in connection with claims for failure to comply with any applicable rules, regulations or other requirements of local, state or federal authorities; for claims of libel, slander, defamation, invasion of privacy, or infringement of common law or statutory copyright, for unauthorized use of trademark, trade name or service mark; for breach of contractual or other obligation, and for any other injury or damage liability in law or equity which claims result from the member/associate's use of Greensboro Community Television.
